Chu lo ah pawh, “fake documents-te & fake claims-te : sum hmuhnan leh mimal hamthatnan inbumna hi, mimal zawngin emaw, phone call in emaw, via social media in emaw, Facebook, YouTube leh Twitter, etc – te kaltlangin emaw “offer” ni awm faharan in, anrawn tider thei che ani.
