- Na thu aman tak leh akicing takin UNHCR ah na puak kei leh, na case vai hong ki awlmawh lo dinga, na vai sawtpi zekai kha thei ding hi/ hong ki huh lo ding hi.
- **UNHCR leh A kizoppihte nasepna khempeuh (UNHCR' zum lai nasepnate: Yayee Card, UN Card, UN ah min khumna, Refugee dinmun khensatna, Resettlement vai leh adangdang huhnate) pen man ngenlo in, amawkna in aki sepsak ahi hi.**
