# LEGAL AID LEAFLET ON LEGAL AID FOR INTERNATIONAL PROTECTION APPLICANTS AND STATUS HOLDERS AND PERSONS UNDER TEMPORARY PROTECTION



## Foreigners in Turkey, including:

- International protection applicants,
- International protection status holders,
- Persons under temporary protection,

may benefit from legal aid in accordance with the principle of fair trial.

### What is legal aid?

Provision of attorney services by bar associations **free of charge** to persons who are unable to pay attorney fees and other trial expenses in whole or partially.

Bar associations are professional organizations for attorneys. There are 79 bar associations in Turkey.

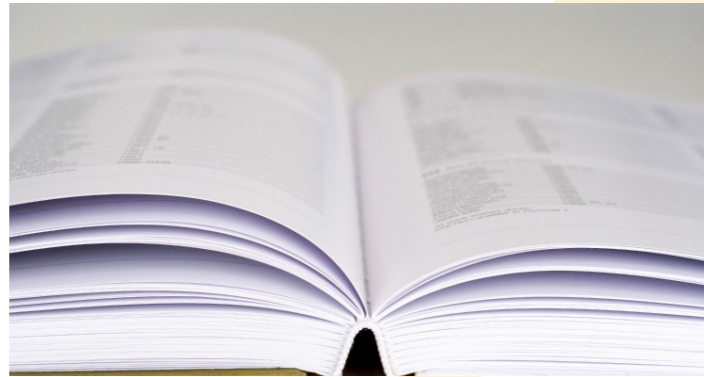
## For what kind of cases I can benefit from legal aid?

### Cases initiated against administrative decisions

This includes deportation orders, administrative detention decisions, rejections of international protection applications and withdrawal decisions.

### Other cases

This includes divorce, guardianship and interim measure, rent, commercial law, and labour law.



**In criminal proceedings, a lawyer may be appointed for you free of charge upon your request. The court may also directly appoint a lawyer for you free of charge in certain circumstances.**

## What do I need to do to benefit from legal aid?

Applications must be lodged to the bar associations or the legal aid bureaus of the bar associations in your province of residence, with:

- **Identification documents,**
- **The decision, contract, etc., that is to be appealed against, if available.**

Bar associations may request other documents (e.g. certificate of residence) to be able to provide you with legal aid.

Power of attorney expenses may have to be covered by the applicant.

**Legal aid may also be requested from the courts. This needs to be clearly indicated in writing in the appeal petition to be submitted to the courts.**
