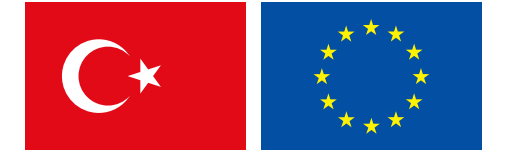

LEGAL ASSISTANCE AND LEGAL AID

The right to benefit from legal assistance and legal aid: is a right provided to foreigners in Türkiye.

During your stay in the Removal Center, you can receive support from an attorney on legal matters provided that you cover the expenses. If you are going to cover the expenses, you have the right to make a contract stating the service you will receive from your attorney and the fee you will pay. You also have the right to request a receipt for the fees paid.

If you are having problems with your attorney following up on your case, you can inform the Bar Association through the officials.

WHAT IS LEGAL AID?

It is provision of free attorney services by the bar associations to those who do not have sufficient means to cover attorney fees and litigation expenses.

Please look at the back page for contact details of Bar Associations.

If your legal aid request is accepted by the Bar Association, you will not pay any attorney fees; however, you will be required to cover the litigation expenses (the costs of applying to the court and expenses incurred at other stages). If you do not have sufficient resources to cover the litigation expenses, inform the attorney assigned to you.

If your legal aid request is rejected by the Bar Association and you need to file an appeal with the Court, you can explain your current situation and request "legal aid" in the petition to be submitted to the Court. After your request is assessed by the Court, a decision may be issued to exempt you from the litigation expenses and to assign an attorney, free of charge, to represent you, based on the assessment conducted.

A power of attorney will be required for the attorney to represent you and you may be required to cover the power of attorney expenses.

WHICH CASES ARE ELIGIBLE FOR LEGAL AID?

One can benefit from legal aid in cases filed against the decisions of the administration. For example, deportation order, administrative detention decision, rejection of international protection application, etc.

Appeal period against deportation order is 7 days, so if you wish to appeal the order, please submit your petition within the specified time limit.

HOW TO APPLY FOR LEGAL AID WHEN UNDER ADMINISTRATIVE DETENTION?

- ➔ You can inform any personnel at the Removal Center about your legal aid request, or you can write a petition in your language indicating your request.
- ➔ After you convey your request verbally, the Removal Center personnel will assist you to put your legal aid request in writing with the help of an interpreter. Your written request will be sent to the relevant Bar Association for evaluation by the Removal Center officials.
- ➔ You can also call the Bar Association at numbers listed on the back page of this brochure or the posters on "free legal assistance" available at the Removal Centre. These calls should be made before 17:00 on weekdays and calls are usually conducted in Turkish.
- ➔ Your family members or other people you know can also contact the Bar Association and request legal aid on your behalf.
